GLEISS LUTZ CONTINUES TO GROW: TWO NEW PARTNERS AND FIVE NEW COUNSEL AS FROM 1 JANUARY 2017

With effect from 1 January 2017, Gleiss Lutz has appointed two new partners: Dr. Martin Viciano Gofferje (corporate/M&A, Berlin) and Dr. Christian von Köckritz (competition/antitrust, Brussels). In addition, Dr. Ines Bodenstein (competition/antitrust, Stuttgart), Dr. Matthias Gärtner (corporate/M&A, Stuttgart), Dr. Carsten Klöppner (competition/antitrust, Stuttgart), Dr. Christian Mencke (corporate/M&A, Hamburg) and Dr. Andreas von Medem (employment, Stuttgart) have been promoted to the role of counsel. These additions underscore Gleiss Lutz's commitment to organic growth in key areas.

Dr. Martin Viciano Gofferje has in recent years assisted clients in complex national and cross-border M&A deals. He also advises on general corporate and capital markets matters. Among other things, he was a member of the Gleiss Lutz team that advised Valeo on its joint venture with Siemens, Blackstone on the acquisition of the Armacell Group and eBay on the sale of ViA-Online GmbH. Another key area of his practice is healthcare. Most recently, he advised Boehringer Ingelheim on a large-volume healthcare cooperation, as well as Leo Pharma on the acquisition of Astellas' dermatology portfolio. Martin Viciano Gofferje further co-heads the firm's Venture Capital Group and has significantly developed and expanded this area at Gleiss Lutz's Berlin office. He assisted Gruner + Jahr with the acquisition of the start-ups Employour, webguerillas and LiquidM.

Dr. Christian von Köckritz advises on European and German antitrust law, in particular in connection with European merger control, cartel investigations and distribution cartel issues, as well as EU state aid and general European law. He has special expertise in conducting complex EU antitrust and merger control proceedings as well as proceedings before the EU courts in Luxembourg, thereby making a key contribution to Gleiss Lutz's growing antitrust practice in Brussels. He was, among other things, a member of the Gleiss Lutz team that represented HeidelbergCement in merger control proceedings regarding the acquisition of a stake in the listed Italian company Italcementi S.p.A. On behalf of GEMA (German Society for Musical Performing and Mechanical Reproduction Rights) as well as the collecting societies PRS for Music (UK) and STIM (Sweden), he secured the clearance of the EU Commission for the formation of a joint venture to issue pan-European licences for online music services. He also obtained a landmark decision for HeidelbergCement before the European Court of Justice. Acting for Evonik Degussa, he was able for the first time to stop the publication of information from its leniency application in interim relief proceedings before the European Court of Justice.

Dr. Ines Bodenstein advises on German and European antitrust law, specialising in issues in connection with cartel proceedings, antitrust damages actions and distribution agreements, especially e-commerce. Ines Bodenstein has already represented well-known companies such as Siemens, Evonik Degussa and LEONI in cartel proceedings and assisted IVECO Magirus with the first collective damages settlement in Germany. Another key focus of her practice involves advising on compliance matters and internal investigations.

Dr. Matthias Gärtner advises on corporate law, specialising in stock corporation and corporate group law.
